### Leetonia Police Department

**618.01 Dogs and other animals running at large; Dangerous and vicious dogs.**

**618.01 (f) Except when a dog is lawfully engaged in hunting and accompanied by the owner, keeper, or harbinger, or handler of the dog, no owner, keeper, or harbinger of any dog shall fail at any time to do either of the following:**

**618.01(f) (1) Keep the dog physically confined or restrained upon the premises of the owner, keeper, or harbinger by leash, tether, adequate fence, supervision, or secure enclosure to prevent escape.**

**618.01(f) (2) Keep the dog under the reasonable control of some person.**

#### Penalties

**618.01(m) (1) Whoever violates divisions (e) or (f) of this section shall be fined not less than twenty-five dollars (\$25.00) or more than one hundred dollars (\$100.00) on a first offense; and on each subsequent offense, shall be fined not less than seventy-five dollars (\$75.00) or more than two hundred fifty dollars (\$250.00) and may be imprisoned for not more than thirty days.**

**618.01(m)(2) In addition to the penalties prescribed in division(m)(1) above, if the offender is guilty of a violation of division(e) or(f) of this section, the court may order the offender to personally supervise the dog that the offender owns, keeps, or harbors, to cause that dog to complete obedience training, or do both.**
