The Tax Department will be mailing the 2006 Village Tax forms out around Mid-January. If you do not receive a form by the end of January and you need one please contact the tax office. Forms also are available at our Website: [www.leetonia.org/](http://www.leetonia.org/)

Taxpayers needing assistance with preparing their Village tax return can:

1. Call the tax dept or
2. Stop in with your tax information (w-2's, 1040, etc) and have it prepared for you at no cost.

The 2006 Village Tax returns must be filed by April 16, 2007. If you receive a tax form and you believe you are not subject to the tax you **MUST** contact the tax dept. All residents with earned income must file. Individuals **UNDER 18** years of age and retired persons with **NO EARNED INCOME** are not liable.

**Delinquent Taxpayers !!** The tax dept. has been citing non-filers and delinquent payers into magistrate's Court. If you are on this delinquent list contact the tax department to clear up your delinquency.
