Customers are responsible for all repairs to water lines from the curb box into the house and any lines inside the structure. The Village of Leetonia will make every effort to assist customers, but once we are dispatched per request of a customer, there is a possibility that a service call fee may apply (\$45.00).

The Leetonia Water Office is requesting that all residents of the Village make sure their information on file at the water office is currently up to date. This information is not used for bill collection purposes, and is only used in case of emergencies or service order appointments. A lot of our residents have changed phone contact information and the water office does not have current information to contact the residents.
