Dear Property Owner –

The Village of Leetonia Ordinance 18-2622 requires **ALL** rental units regardless of rentability are to be registered on or by May 15th of every year and sets forth regulations for rental properties in the Village of Leetonia, State of Ohio.

Each **new or renewal** registration shall be valid for one (1) year and shall expire on May 15th of each year. The non-refundable fee for registration is twenty **(\$20.00)** dollars per unit if paid on or before **May 15, 2022**.

Registration is not assignable or transferable, therefore each **new owner** of a rental unit shall make application and submit a non-refundable fee of twenty (\$20.00) dollars per unit within thirty (30) days after acquiring ownership.

If a new or renewal application and non-refundable registration fee is received after May 15, 2022, the registration fee will be fifty (\$50.00) per unit and after sixty (60) days a citation to Municipal Court, Lisbon Ohio shall be issued to the property owner.

Please take a moment to complete the attached registration form. It is required that a registration form be completed for each unit. **PLEASE DO NOT WRITE (SAME) ON REQUIRED LINES EVEN IF THERE HAVE BEEN NO CHANGES.**

If the unit is unrentable because it is being remodeled, a family member is living there and is not paying rent, or for some other valid reason, the owner/agent must submit and sign the application, fee and a letter stating why the unit is unrentable.

Rental properties may be subject to inspection by the designated village official in accordance with Ordinance 18-2622. Ordinance 18-2622 can be viewed at www.leetonia.org or at the office of the Leetonia Fiscal Officer, Village Hall, 300 E. Main Street, Leetonia, Ohio 44431.
