# Village Income Tax Deadline is April 17<sup>th</sup>.

The Regional Income Tax Agency (RITA) invites all taxpayers who are required to file a municipal income tax return for any RITA municipality to receive free assistance for your 2017 forms. To receive assistance please have all necessary tax documentation, including the following:

- W-2 Forms from all employers, and any W-2G Forms and 1099-MISC Forms
- Federal Form 1040, Federal Schedules C, E & F, Federal forms K-1, 2106 (if applicable)

Customer service agents are available to help answer taxpayer questions and provide assistance by calling toll-free at 1-800-860-7482. Agents are available Monday through Friday from 8 am until 5 pm.

**2018 Quarterly Estimated Taxes are also due April 17<sup>th</sup>.** If you think you are going to owe more the \$200 in taxes for 2018 you are required by State law to pay quarterly estimated payments. Call RITA (1-800-860-7482) for more information.
