VILLAGE OF LEETONIA, OHIO

AN ORDINANCE ESTABLISHING FEES FOR THE PURCHASE OF GRAVE SITES AND BURIALS AT OAKDALE CEMETERY AND THE DISTRIBUTION OF SUCH PROCEEDS, ALL FOR THE VILLAGE OF LEETONIA, STATE OF OHIO.

WHEREAS, the Cemetery Board has reviewed the current Fee Ordinance and has recommended changes to the same; and

WHEREAS, the Village feels that it is in the best interest of the municipality to adopt the recommendations of the Cemetery Board; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LEETONIA, STATE OF OHIO:

SECTION ONE: That the fees at Oakdale Cemetery are as follows:

- A. \$500.00 for the purchase of a full-size grave site. The proceeds from such sale shall be deposited as follows:
1. \$415.00 to Cemetery Fund
 2. \$10.00 to Perpetual Care Fund
 3. \$75.00 to Capital Improvement Fund

- B. \$800.00 for the opening and closing of a full-size grave site on Monday – Friday from 9:00 a.m. to 4:00 p.m. The proceeds shall be deposited as follows:
1. \$675.00 to the Cemetery Fund
 2. \$125.00 to the Chapel Fund

In the event a burial is schedule outside of the hours shown above, an additional charge of \$100.00 will be charged. The proceeds from this additional charge shall be deposited as follows:

1. \$100.00 to Capital Improvement Fund

- C. \$300.00 for a cremation burial (opening and closing) on Monday – Friday from 9:00 a.m. to 4:00 p.m. The proceeds shall be deposited as follows:
1. \$150.00 to the Cemetery Fund
 2. \$50.00 to the Chapel Fund
 3. \$100.00 to the Capital Improvement Fund

In the event a cremation burial is schedule outside of the hours shown above, an additional charge of \$100.00 will be charged. The proceeds from this additional charge shall be deposited as follows:

1. \$100.00 to Capital Improvement Fund

E. \$300.00 for an infant burial (opening and closing) on Monday – Friday from 9:00 a.m. to 4:00 p.m. The proceeds shall be deposited as follows:

1. \$235.00 to the Cemetery Fund
2. \$65.00 to the Chapel Fund

In the event an infant burial is schedule outside of the hours shown above, an additional charge of \$100.00 will be charged. The proceeds from this additional charge shall be deposited as follows:

1. \$100.00 to Capital Improvement Fund

SECTION TWO: That all Ordinances and Resolutions, or parts thereof, that are in conflict with the provisions of the within Ordinance are hereby repealed. Ordinances and Resolutions, or parts thereof, which are not in conflict are to remain in full force and effect.

SECTION THREE: That this Ordinance shall take effect and be in full force from and after the earliest period allowed by law.


