FORECLOSURE REGISTRATION

The Village of Leetonia Ordinance 12-2347 requires a filing fee for "Notification of Foreclosure Filing" to be filed with the Zoning Officer within ten (10) days of a foreclosure complaint being filed with the relevant court; the fee is seventy-five (\$75.00) dollars. The filing fee for "Notification of Foreclosure" to be filed with the Zoning Officer more than ten (10) days after the foreclosure complaint is filed with the relevant court is one hundred (\$100.00) dollars. The fee shall be paid at the time of notification.

Any person who fails to comply with the notification and/or fee requirements of this ordinance is guilty of a minor misdemeanor and shall be not fined more than one hundred and fifty dollars (\$150.00). Each day during which noncompliance continues shall be considered a separate offense.

Foreclosed properties require a person responsible for maintenance in accordance with Ordinance 12-2347. Ordinance 12-2347 can be viewed at www.leetonia.org or the office of the Leetonia Fiscal Officer, Village Hall, 300 E. Main Street, Leetonia, Ohio 44431.
