The following documents are required to obtain a Zoning/Building Permit:

- 1. Complete an Application Form and submit the non-refundable fee.

 Please see fee schedule to determine the correct fee for your submittal.
- 2. Submit Plans of the new, modified structure, addition, and interior remodel (only applies to interior remodel if moving walls/creating rooms).
- **3.** A list of all contractor names, addresses, phone numbers and skilled trades (example: framer, carpenter, plumber etc.) **NOTE: All Contractors must be registered to perform work in the Village of Leetonia.**
- 4. Site drawing showing:
 - a) Lot size
 - b) Existing structures with size and distance from property lines.
 - c) Proposed structures or additions to property or dwellings with size and distance from property line.
 - d) A floor plan.
