



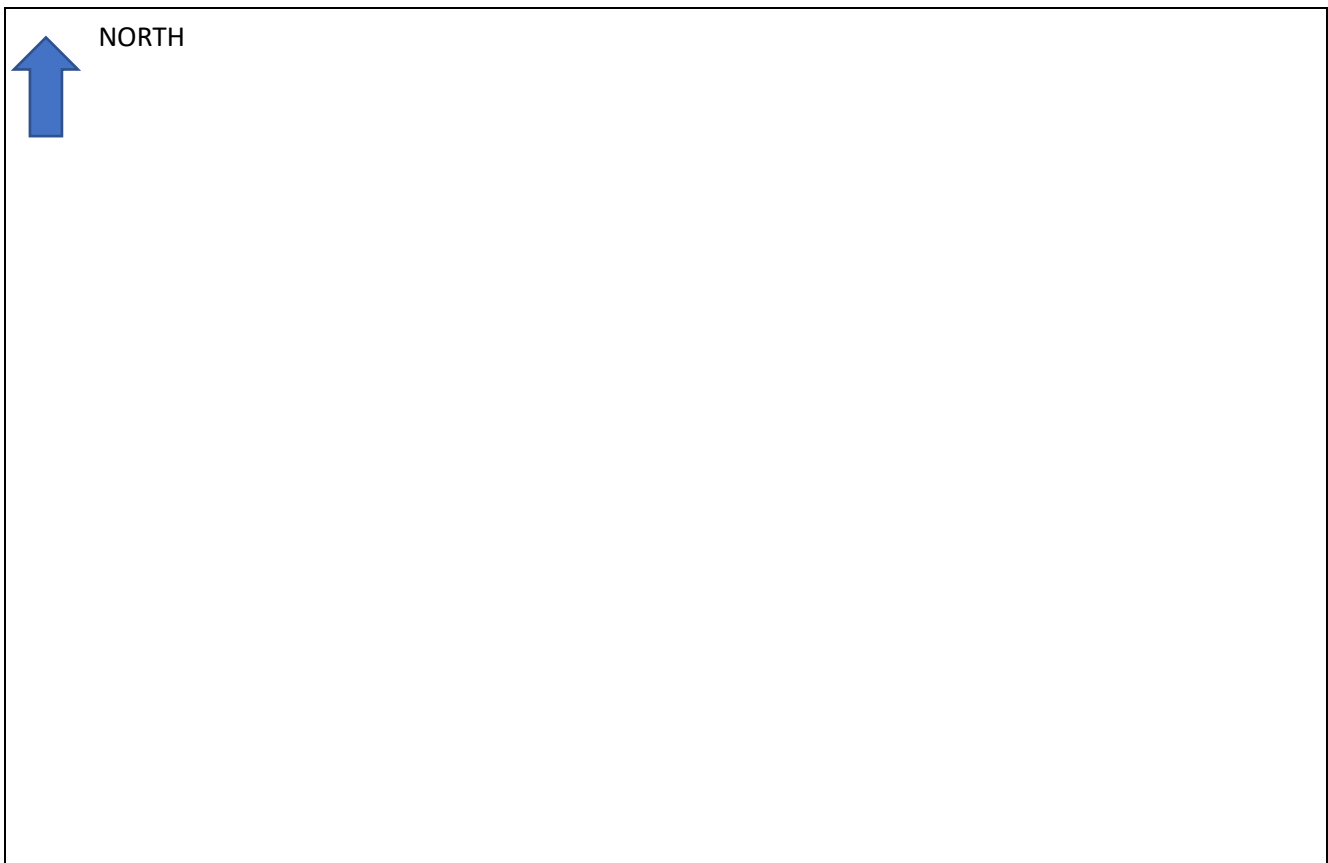

The following documents are required to obtain a Zoning/Building Permit:

1. Complete an Application Form and submit the non-refundable fee.
Please see fee schedule to determine the correct fee for your submittal.
2. Submit Plans of the new, modified structure, addition, and interior remodel (only applies to interior remodel if moving walls/creating rooms).
3. A list of all contractor names, addresses, phone numbers and skilled trades (example: framer, carpenter, plumber etc.) **NOTE: All Contractors must be registered to perform work in the Village of Leetonia.**
4. Site drawing showing:
 - a) Lot size
 - b) Existing structures with size and distance from property lines.
 - c) Proposed structures or additions to property or dwellings with size and distance from property line.
 - d) A floor plan.
